## T1.1: TENDER NOTICE AND INVITATION TO TENDER

Kareeberg Municipality invites tenders for "The upgrading of sport complex (Phase 1) in Carnarvon"

Tenders must be registered with the CIDB in a CE/GB Class of construction works and have a grading designation equal to 4CE or 4GB with the Construction Industry Development Amendment Regulations, 2008, which became effective on 01 January 2009.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders.

Tender documents will be available at the compulsory site inspection.

A non-refundable tender deposit of R300.00, payable in cash or by bank guaranteed cheque made out in favour of Kareeberg Municipality is required on collection of the tender documents.

A compulsory site inspection will be conducted by the Engineer at the Kareeberg Municipality, Hanau, Street, Carnarvon, 8780 on Wednesday, 15<sup>th</sup> January 2014 starting at 10:00. Persons arriving later than 10:15 will not be allowed into the meeting. Only tenderers who attend the compulsory site inspection meeting are eligible to submit tenders.

The Kareeberg Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act shall apply in the adjudication and awarding of the tender.

## The following conditions shall apply:

- The Municipality is not obliged to accept the lowest or any tender and reserves the right to accept any
  tender or portion thereof if; (a) the tender-amounts received are too high; (b) the tenderers do not
  comply with the specific tender goals; or (c) objective criteria exist which justify or necessitate the nonacceptance of any tenders.
- Tenders must be valid for a period of 8 weeks after the closing date.
- Kareeberg Municipality's Supply Chain Management Policy will apply.
- Tenders will be evaluated on the 90/10 preference point system.
- Tenderers must register on the Kareeberg Municipality Database.
- All documentary proof such as original tax clearance certificates etc. must be submitted with the tender.
- Telefax, telegram, email and late tenders will not be accepted. Tenders may only be submitted on the tender document that is issued.

The closing time for receipts of tenders is 12h00 on Friday, 31 January 2014. Sealed tenders, endorsed with the corresponding tender number and description, must be placed in the tender box at the offices of Kareeberg Municipality in Carnarvon.
