

# Kareeberg Munisipaliteit

## 36/2020 KWOTASIE: PLASTIESE VULLISSAKKE

Skriftelike kwotasies word hiermee ingewag vir die verskaffing en aflewering v.o.s. Carnarvon van 90 000 by 40 mikron swart plastiese sakke (750mm x 950mm), verpak in hoeveelhede van ses-en-twintig per pak met die nodige sakbinders. Kwoteerders se aandag word daarop gevestig dat aflewering van die helfte by die toekenning van die kwotasie moet geskied en die balans drie maande later.

Kwoteerders moet hulle belastingnakomingsstatus PIN verstrek. Die unieke MAAA nommer moet ook op die Kwotasie verstrek word. Kwotasies sal verwerp word indien die voorgeskrewe verklaring van belange vorm (MBD 4) nie aangeheg is nie, sowel as die MBD 1. Die ingevulde vorms MBD 6.1, MBD 8 en MBD 9 moet ook aangeheg wees met bewyse dat geen gelde aan 'n munisipaliteit verskuldig is nie, ten opsigte van dienste en eiendomsbelasting. In geval van 'n maatskappy moet die direkteure se rekenings aangeheg word. Die 80/20 puntestelsel is van toepassing. Written quotations are hereby invited for the supply and delivery, free on track, at Carnarvon of 90 000 of 40 micron black plastic bags (750mm x 950mm), packed in amounts of twenty-six per pack with the necessary pocket binders. Quoters attention is drawn to the fact that half of the delivery should be made on the quotation and the balance three months later.

Quoters must provide their tax compliance status PIN. The unique MAAA number must also be provided on the kwotasie. Quotations will be rejected if the prescribed statement of interest form (MBD 4) is not attached, as well as the MPD 1. The completed forms MBD 6.1, MBD 8 and MBD 9 must also be attached with proof that no fee to a municipality owing to services and property taxes. In the case of a company, the directors' accounts must be attached. The 80/20 points scheme applies.
